

**WHEREAS, RECOT, INC.**, incorporated in the state of Delaware, with a place of business at 5000 Hopyard Road, Suite 460, Pleasanton, California 94588 (hereinafter referred to as "**Assignor**"), is the sole owner, by virtue of an assignment duly recorded in the United States Patent and Trademark Office at Reel/Frame pending, of certain new and useful improvements in **Extruded Granola Process**, for which an application for a United States Patent was filed on September 5, 2003, U.S. Serial No. 10/656,712, with attorney reference number CFLAY.00205 (hereinafter referred to as the "**Invention**"); and

**AND ASSIGNOR HEREBY** covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.


