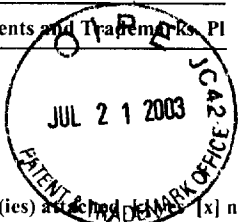



We hereby authorize said Assignee to pursue claims for past infringement and damages including provisional rights damages.


