ASSIGNMENT

WHEREAS we, Horst ECKERT, a citizen of Germany, having an address of Kukshagen 4, 31547 Rehburg-Loccum, Germany, and Arnd GAULKE,, a citizen of Germany, having an address of Triftstraße 22, 31952 Ronnenberg, Germany, (hereinafter referred to as the "ASSIGNORS"), have invented certain new and useful improvements in **SYSTEM AND METHOD FOR CONTROLLING BRAKE ACTUATION ENERGY IN ELECTRONICALLY-CONTROLLED VEHICLE BRAKE SYSTEMS**, for which an application for Letters Patent of the United States was filed on April 29, 2003, and was assigned Serial No. 10/426,965; and

WHEREAS, WABCO GmbH & Co. OHG., a German company, having an address of Am Lindener Hafen 21, 30453 Hannover, Germany (hereinafter referred to as the "ASSIGNEE"), is desirous of obtaining the entire right, title and interest in, to and under the improvements and the application;

NOW, THEREFORE, in consideration of the sum of Five Dollars (\$5.00) and other good and valuable consideration paid by ASSIGNEE to ASSIGNORS, the receipt of which is hereby acknowledged, ASSIGNORS have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the improvements, and the application and all divisions, renewals, substitutes and continuations thereof, and all Letters Patent of the United States that may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent and any legal equivalent thereof, including the right to claim priority, that have been or may hereafter be filed for the improvements in any country or countries foreign to the United States, and all Letters Patent and any legal equivalent thereof that may be granted for the improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof, the same to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives fully and entirely as if the same would have been held and enjoyed by ASSIGNORS if this Assignment had not been made, to the end of the term or terms for which any Letters Patent and any legal equivalent thereof may be granted;

AND ASSIGNORS HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to record this Assignment, and to issue all Letters Patent for the improvements to ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;






