applications for Letters Patents which may hereafter be filed for
said improvements in any country or countries foreign to the
United States, and all Letters Patents which may be granted for
said improvements in any country or countries foreign to the
United States, and any official of any country or countries
foreign to the United States, whose duty it is to issue patents,
on applications as aforesaid, to issue all Letters Patents for
said improvements to said Assignee, its successors, legal
representatives and assigns, in accordance with the terms of this
instrument.

AND I/WE HEREBY covenant that I/we have full right to
convey the entire interest herein assigned, and that I/we have not
executed, and will not execute, any agreement in conflict herewith.

AND I/WE HEREBY further covenant and agree that I/we
will communicate to said Assignee, its successors, legal
representatives and assigns, any facts known to me/us respecting
said improvements, and testify in any legal proceeding, sign all
lawful papers, execute all divisional, continuing and reissue
applications, make all rightful oaths and generally do everything

possible to aid said Assignee, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
