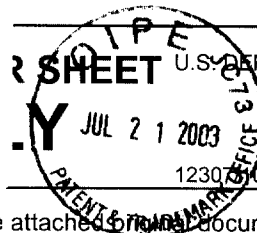

protection for said improvements and for vesting title to said improvements, and all applications for patents and all patents on said improvements, in ASSIGNEE, its successors, assigns, and legal representatives.
