ASSIGNMENT OF PATENT RIGHTS

Whereas Intellectual Ventures Patent Holding I, L.L.C., a Delaware limited liability company, with an office at 1422 130th Ave NE, Bellevue, WA 98005 ("**Purchaser**") is desirous of acquiring the right, title and interest in, to and under the said Patents.

Now, Therefore,

For good and valuable consideration, the receipt of which is hereby acknowledged, Seller does hereby sell, assign, transfer and set over to Purchaser, the Patents aforesaid, any reissue or reissues of said Patents already granted and which may be granted, any certificates of reexamination already granted and which may be granted the same to be held and enjoyed by Purchaser for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which said Patents are or may be granted, reissued or extended as fully and entirely as the same would have been held and enjoyed by Seller, if this assignment and sale had not been made.

And, Seller, hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patents of the United States on said inventions to Purchaser as assignee of the entire interest, and hereby covenants that Seller has full right to convey the entire interest herein assigned, and that, except as otherwise provided between the parties, Seller has not executed, and will not execute, any agreements in conflict therewith.

This Assignment of Patent Rights is entered into pursuant to that certain Asset Purchase Agreement, dated as of May 27, 2003, by and between Seller and Purchaser, and is subject to the terms of such agreement in all respects.
