

rightful oaths and do all lawful acts requisite for the application for such divisional, continuing or reissue applications, or the procuring thereof, and that if and when said COOKGAS, LLC., its successors, assigns, nominees or other legal representatives desire to file a disclaimer relating thereto, I will, upon request, sign and deliver all lawful papers requisite for the filing of such disclaimer, and I further covenant and agree that I will, at any time upon request, do everything possible to aid said COOKGAS, LLC., its successors, assigns, nominees or other legal representatives, either in my or its own name, to apply for, obtain and enforce proper patent protection for said improvements in all countries according to the International Convention of 1883 and all the laws and treaties in force, all without further consideration but at the expense of said COOKGAS, LLC., its successors, assigns, nominees or other legal representatives.

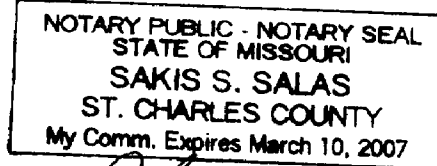
