**CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION OF**

KAMYR, INC.

Kamyr, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, (the "Corporation") DOES HEREBY CERTIFY:

1. The name under which the Corporation was originally incorporated is Kamyr, Inc. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on December 16, 1952.

2. The following amendment to the Certificate of Incorporation was approved by the Board of Directors and the Stockholders of the Corporation in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware:

"RESOLVED, That the Certificate of Incorporation of this Corporation be amended by changing Article FIRST thereof so that, as amended, said article shall be and read as follows:

'FIRST: The name of the corporation is AHLSTROM MACHINERY INC. '"

3. The necessary number of shares as required by statute were voted in favor of said amendment.

4. The capital of the Corporation will not be reduced under or by reason of said amendment.
