

Deed of Assignment

Dated **23 May**

Between:

- (1) **Lindsey Julia-Jane Walker and Shelley-Anne Salisbury** both c/o 21 Cyprus Road, London N3 1SS (the Assignors); and
- (2) **Linshell Holdings Limited** whose registered office is at 21 Cyprus Road, London N3 1SS (the Assignee).

Whereas

- (A) The Assignors are entitled to the benefit of the United Kingdom and the United States of America patent applications, short particulars of which are set out in Schedule 1 hereto (the **Patent Applications**).
- (B) The Assignors are the registered proprietors of the registered designs, short particulars of which are set out in Schedule 2 hereto (the **Registered Designs**).
- (C) The Assignors are the registered proprietors of the trade mark applications together with the goodwill attaching to the same, short particulars of which are set out in Schedule 3 hereto (the **Trade Marks**).
- (D) The Assignors own certain works set out in Schedule 4 hereto (the **Works**).
- (E) The Assignors wish to assign the Patent Applications, the Registered Designs, the Trade Marks and the Works to the Assignee.

NOW THIS ASSIGNMENT WITNESSES as follows:

- 1 In consideration of the sum of £1 (one pound) now paid by the Assignee to the Assignors (receipt of which the Assignors hereby acknowledge) the Assignors with full title guarantee hereby assign to the Assignee the Patent Applications, the Registered Designs, the Trade Marks, the Works and the right to apply for patent, registered design, trade mark or similar protection in relation to the same in any part of the world (including the right to rely on any convention priority period) and all property, right, title and interest therein together with the right to sue for and recover damages in respect of all infringements and threatened infringements of the Patent Applications, the Registered Designs, the Trade Marks and the Works prior to the date hereof.
- 2 Upon request by and at the cost of the Assignee and without unreasonable delay the Assignors shall:
 - 2.1 assist with the prosecution of the Patent Applications and execute all such documents and do all such acts as may be necessary for procuring the grant of patents pursuant to the Patent Applications in the name of Assignee;
 - 2.2 in the event that any proceedings are commenced relating to the validity, scope, inventorship of, or ownership of any patent granted pursuant to the Patent Applications pursuant to which

the Assignors have or can procure information which may assist in defending such challenge, supply or procure the supply of such information;

2.3 at any time execute any further documents and carry out any acts reasonably required to give effect to this Assignment.

3 This Assignment shall be governed by English law and the parties hereto submit to the exclusive jurisdiction of the English Courts.




