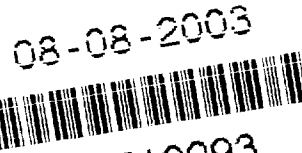


WITNESSETH THAT:


