**AND, WE** request the Commissioner of Patents and Trademarks to issue any Letters Patent of the United States which may be issued for said invention to said **BRIGHTWELL DISPENSERS LIMITED**, its legal representatives, successors, or assigns, as the sole owner of the entire right, title and interest in and to said patent and the invention covered thereby.
