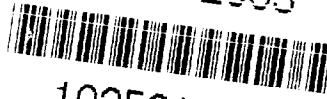

AND we hereby agree to execute, upon request, any and all further papers which may be necessary or desirable to enable the said **MITEL**


