**PATENT ASSIGNMENT  
FROM LETRO PRODUCTS, INC. TO PENTAIR POOL PRODUCTS, INC.**

**THIS PATENT ASSIGNMENT** ("Assignment") is made effective as of the 26th day of February, 2003, by and between Letro Products, Inc., a California corporation (hereinafter "Assignee"), and Pentair Pool Products, Inc., a Delaware corporation (hereinafter "Assignor").

**WHEREAS**, Assignor is the owner of the entire right, title and interest in and to the patents and patent applications (as well as the inventions disclosed therein) identified on Schedule A attached hereto (collectively, the "Patents and Patent Applications"); and

**WHEREAS**, Assignor and Assignee are parties to the Asset Purchase Agreement, dated as of February 24, 2003 ("APA"), which provides for, among other things, the assignment of the Patents and Patent Application, from Assignor to Assignee, together with all goodwill associated therewith and all common law rights therein.

**NOW, THEREFORE**, in consideration of One Dollar (\$1.00) and the mutual covenants and obligations contained herein and in the APA, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

Assignor does hereby sell, assign and transfer to Assignee, its successors and assigns, all of its worldwide right, title, and interest, in and to the Patents and Patent Applications, set forth on Schedule A, together with all of the inventions disclosed therein, and all income, royalties, fees, damages, and payments now or hereafter due or payable with respect thereto, and in and to any and all causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement, misappropriation and/or dilution of the Patents and Patent Applications and any other rights assigned to Assignee under this Agreement.

Assignor covenants and agrees to execute or procure any further necessary assurance of title to said Patents and Patent Applications; and at any time, upon the reasonable request and at the expense of said Assignee, will execute and deliver any and all papers that may be necessary or desirable to perfect the title to said Patents and Patent Applications, in Assignee, its successors, assigns or other legal representatives; and to make a record with any and all government agencies, authorities, courts, tribunals, or third parties, of the fact that Assignee owns all right, title and interest in and to the Patents and Patent Applications, and any and all goodwill associated therewith, and that Assignor no longer has any right, title or interest, of any kind or nature, in or to the Patents and Patent Applications.

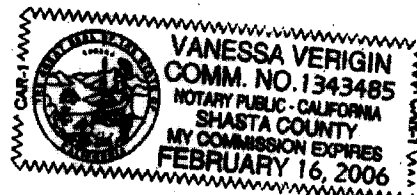
