TERMINATION, RELEASE AND REASSIGNMENT OF SECURITY INTEREST

This Termination, Release and Reassignment of Security Interest (this "Release"), dated as of March 03, 2003, is executed by BERG & BERG ENTERPRISES, LLC, a California limited liability company ("Berg"), as an agent for itself and for each of the other parties described on Schedule 1 attached hereto, (collectively, "Secured Parties") and HUNTINGTON TECHNOLOGY FUND L.P., a California limited partnership ("Huntington") as agent for itself and for each of the other Secured Parties, in favor of GYRATION, INC., a California corporation (the "Company"). Pursuant to the terms of the IP Security Agreement, the Company granted the Agent, for the ratable benefit of the Secured Parties, a security interest in, all of the Company's right, title and interest in and to all Copyrights, Patents, Patent Licenses, Trademarks, Trademark Licenses and Trade Secrets ("Intellectual Property") listed on Exhibits A, B, and C hereto (collectively the "Intellectual Property Collateral") including without limitation, all Proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.
- C. On August 19, 2002, the Agent, as agent for itself and for each of the other Secured Parties, recorded a Grant of Security Interest ("IP Assignment") with the United States Patent and Trademark Office, as document No. 102194501, at Reel 013193, Frame 0007.
- D. The Obligations of the Company pursuant to which the Security Agreement and IP Security Agreement were entered into, have been paid in full and fully performed. The Agent, as agent for itself and for each of the other Secured Parties, has delivered to the Company, at the Company's sole cost and expense, such documents that the Company has reasonably requested to evidence such termination, in each case in accordance with the provisions of the Security Agreement and the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Any right, title and interest of the Agent in, to and under the Collateral and Intellectual Property Collateral shall hereby cease and become void, and the IP Assignment shall hereby terminate.


