WHEREAS, the undersigned, Karam Michael Noujeim, a resident of Sunnyvale, California, (hereinafter termed "Inventor"), has invented certain new and useful improvements in:

LEAKY WAVE MICROSTRIP ANTENNA WITH A PRESCRIBABLE PATTERN
