PATENT ASSIGNMENT

RECITALS

A. WHEREAS, ASSIGNOR, presently owns or controls certain patents and patent applications listed in the attached Appendix A; and

B. WHEREAS, ASSIGNOR, presently owns or controls certain patents and patent applications, desires to transfer, assign, convey, deliver and vest all of its interests and rights in, to ASSIGNEE.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to ASSIGNEE the entire right, title and interest in and to said patents and patent applications, and all divisions and continuations thereof, and all United States Letters Patents which may be granted on said applications and all reissues, reexaminations and extensions thereof, and all priority rights under all available International Agreements, Treaties and Conventions for the protection of intellectual property in its various forms in every participating country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said improvements in any foreign countries claiming priority of any of said patents or applications, and all patents (including all continuations, divisions, extensions, renewals, substitutes, and reissues thereof) granted thereon in any foreign countries; and ASSIGNOR hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all such patents to ASSIGNEE in accordance with the terms of this Assignment;

AND ASSIGNOR HEREBY covenants that it has full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to ASSIGNEE any facts known to them in respect to said patents and applications, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said patents and applications in all countries.
