I authorize and empower the said Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any applications for patent or other


form of protection for said invention filed by it of them, the benefit of the right of priority provided by the International Convention of the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written authorization from me.

I covenant with said Assignee, its successors, assigns and legal representatives, that the rights and property herein conveyed are free and clear of any encumbrance, and that I have full right to convey the same as herein expressed.
