

ASSIGNMENT OF UNITED STATES TRADEMARK
AND PATENTS

This Assignment is made March 9, 2004, effective as of July 29, 2002, nunc pro tunc, by BQX Ltd. (in liquidation) (formerly APW Ltd.), a Bermuda company ("Assignor") having a place of business at Wildey Business Park, Wildey Road, Parker House, St. Michael, Barbados, for the benefit of APW Ltd. (formerly known as AWP Ltd.), a Bermuda company ("Assignee") having a place of business at 2 Church Street, Hamilton, Bermuda.

WHEREAS, Assignor is or may be the owner of the entire right, title and interest in and to the United States Trademark Application No. 76/428,539 (the "Application"), and the corresponding trademark PROFILE (the "Trademark"); and

WHEREAS, Assignor is or may be the owner of the United States Patents as listed in the attached Schedule of Patents (the "Patents"); and

WHEREAS, Assignee desires to acquire from Assignor the Trademark and the Application, and the goodwill of the business in connection with which the Trademark and the Application are used; and

WHEREAS, Assignee desires to acquire the Patents from Assignor; and

WHEREAS, Assignee acquired most of the assets and certain specified liabilities of Assignor and is the successor to the business of Assignor;

NOW, THEREFORE, in consideration of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor agrees to sell, assign, and transfer to Assignee, its successors and assigns, and does hereby sell, assign, and transfer to Assignee, its successors and assign (1) Assignor's entire right, title, and interest in and to the Trademark and the Application, and


the goodwill of the business symbolized by the Trademark and the Application and in connection with which the Trademark is used, (2) Assignor's entire right, title, and interest in and to the Patents, and (3) all claims and demands, if any, including all claims and demands for past infringement, that Assignor may have in connection with the Trademark or the Application or the Patents arising before and as of the date of this Assignment.

Assignor and Assignee acknowledge that, effective July 29, 2002, Assignor assigned most of its assets and certain specified liabilities to Assignee and that Assignee is the successor to the business of Assignor.

The terms and provisions of this Assignment shall inure to the benefit of Assignee and its successors and assigns, and shall be binding on Assignor and its legal representatives.


