

**ARTICLES OF AMENDMENT
TO
1990 RESTATED ARTICLES OF INCORPORATION
OF
IN FOCUS SYSTEMS, INC.**

Pursuant to ORS 60.447, the undersigned corporation hereby submits for filing the following Articles of Amendment to its 1990 Restated Articles of Incorporation (the "Restated Articles of Incorporation"):

1. **Name of Corporation Prior to Amendments:** In Focus Systems, Inc.

2. **Amendment No. 1.** Article I of the Restated Articles of Incorporation is amended to read as follows:

ARTICLE I

The name of the corporation shall be InFocus Corporation and its duration shall be perpetual.

3. **Amendment No. 2.** Article III of the Restated Articles of Incorporation is amended to read as follows:

ARTICLE III

The aggregate number of shares that the Corporation shall have authority to issue is 150,000,000 shares of Common Stock.

4. **Date of Adoption of Amendments:** May 31, 2000

5. **Shareholder Vote:** Shareholder action was required to adopt both Amendment No. 1 and Amendment No. 2. The shareholder vote was as follows:


