ASSIGNMENT

WHEREAS, I, Sverrir Olafsson, residing at Thingholtsstraeti 14, Reykjavik, Iceland, have invented certain new and useful improvements disclosed in an application for United States Letters Patent titled Quick Connect Parameter Exchange, filed on April 24, 2000 as application serial no. 09/557,233;

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to Assignee any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths, and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.
