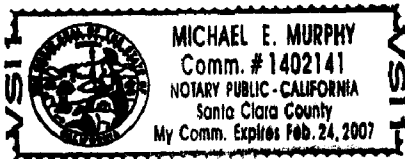
WHEREAS,

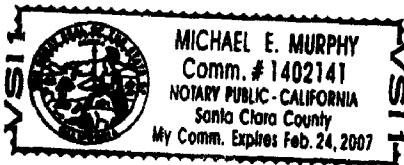

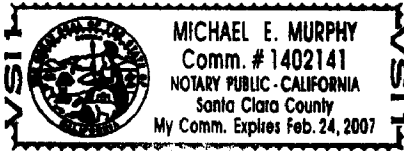
