### QUITCLAIM ASSIGNMENT

This Quitclaim Assignment is made effective this 26<sup>th</sup> day of February 2004, by and between Keith Withycombe, Patty Withycombe, Melissa Goett, and Vincent Goett, individuals (hereinafter referred to as "Assignors") and Augusta Holdings LLC, an Arizona limited liability company, with a principal place of business at 6400 North 48<sup>th</sup> Street, Paradise Valley, Arizona 85253 (hereinafter referred to as "Augusta").

Any assets, collateral, Patents, or proceeds thereof recovered by Augusta shall belong to Augusta and the unpaid balance, if any, of the obligations secured by the said security interests shall remain the property of Assignors.
