Pursuant to Section 242 of the Delaware General Corporation Law

Emtera Corporation, a Delaware corporation (the "Corporation"),
HEREBY CERTIFIES:

FIRST: The Certificate of Incorporation of the Corporation was
filed in the Office of the Secretary of State of Delaware on March 1, 2000.

SECOND: The Certificate of Incorporation is amended to change
the corporate name by striking Article 1 of the Certificate of Incorporation in its
entirety and inserting the following new Article 1 as follows:

"The name of the Corporation is **Brickstream Corporation**
(the "Corporation")."

THIRD: This Amendment to the Certificate of Incorporation
