# ASSIGNMENT

**WHEREAS**, we, Shigeo NAKATERA, Tomohisa MIKAMI, and Tetsuro OZAWA, citizens of Japan, respectively, have invented certain new and useful improvements in a CATHODE-RAY TUBE, CATHODE-RAY TUBE APPARATUS, IMAGE DISPLAY APPARATUS, AND COIL UNIT for which we have executed application for Letters Patent of the United States, assigned Serial No. 10/437,210 filed May 13, 2003

INDUSTRIAL CO., LTD., its successors, legal representatives and assigns, in accordance with the terms of this instrument.

**AND WE HEREBY** covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

**AND WE HEREBY** further covenant and agree that we will communicate to said MATSUSHITA ELECTRIC INDUSTRIAL CO., LTD., its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid said MATSUSHITA ELECTRIC INDUSTRIAL CO., LTD., its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
