## ASSIGNMENT

WHEREAS We, *Larry B. McAllister, Jr.*, residing at 204 Julien Place, Spartanburg, SC 29301, *Dwight W. Schwark*, residing at 226 N. Orchard Farms Ave., Simpsonville, SC 29681, *Larry W. And we do hereby agree for ourselves and for heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which CRYOVAC, INC., its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title, and interest in and to and the full enjoyment of said invention or any part

therefor and the said Letters Patent or any of them, the same to be done without any further consideration.


