Agreement

This assignment, effective as of Oct. 21, 2002, by and between Civcom Inc. a company organized under the laws of the State of Delaware (the "Company"), and CIVCOM Devices & Systems Ltd., a company organized under the laws of the State of Israel (the "Subsidiary");

- Whereas According to few Patent registers records, worldwide, (the "Records"), the Company is designated as the assignee of few patents and patent applications, all detailed in Annex A to this agreement (the "Patents");
- Whereas The Records were mistakenly recorded in such a way as to distort the initial intentions and rights of the parties; and
- Whereas The Subsidiary should have been, originally, recorded as the Patents's assignee;
- Whereas The Parties, in order to reflect their initial intentions, have in good faith decided to amend these certain Records by way of executing this agreement;

NOW, THEREFORE, the Company and the Subsidiary hereby agree as follows:

1. The Subsidiary, its successors, assigns, nominees or other legal representatives, are the exclusive owner of the entire rights, titles and interests, in and to the patents, and all patent applications derived therefrom, and all original and reissued patents granted therefore, and any and all continuations and divisions thereof, including, but not limited to, any and all extensions, reexaminations, substitutes and renewals, and including the right to apply for and obtain patents in all countries, the priority rights under International Conventions, and any and all letters patent which may be granted thereon; all rights to collect and retain all royalties and other considerations arising from said patent applications; and all rights to sue for past, present and future infringement; and the right to collect and retain all damages collected or awarded there under;

2. The Company authorizes and requests any Official of any country whose duty it is to issue patents on applications as aforesaid. to issue said Letters Patent to said Subsidiary, its successors, assigns, nominees or other legal representatives, for the sole use and benefit of said Subsidiary, its successors, assigns, nominees or other legal representatives;
3. The Company agrees to sign all lawful papers, make all rightful oaths, do all lawful acts requisite for such patent applications, and do everything possible to aid said Subsidiary, its successors, assigns, nominees or other legal representatives, to apply for, obtain and enforce patent protection for the Patents.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement in one or more counterparts as of the date first above-mentioned.


