**ASSIGNMENT**

WHEREAS, I Phillip C. Apple depose and say that I am a citizen of the United States residing at RD 1, Mt. Pleasant Mills, PA 17853, County of Snyder, State of Pennsylvania, and being the inventor of a certain invention for MAIN EVENT UMBRELLA, for which I have made application for United States Letters Patent by application executed, case number 1568.

WHEREAS, AMERICAN HOLTZKRAFT, INC., a corporation, organized and existing under the laws of the State of Pennsylvania, with its principal office at Box 65, Mt. I also hereby sell, assign, transfer and set over to said AMERICAN HOLTZKRAFT, INC., its successors and assigns, my foreign rights to the invention disclosed in said application in and for all patent-granting countries of the world, including the right to file applications and obtain patents for said invention in its own name in said countries and including all right of priority in said countries under the terms of the International Convention for the Protection of Industrial Property derived from my aforesaid United States application for Letters Patent (Case number 1568) and I further agree to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights.

I hereby further covenant and agree that I will, at any time, upon the request of said assignee, or its successors, assigns, and legal representatives or papers, execute any and all divisional, continuation, reissue and substitute applications, make all lawful oaths, and at the expense of said assignee company, testify in any legal proceedings that may be necessary or desirable to secure to said assignee the full enjoyment of the rights and properties herein conveyed or intended to be conveyed, in order to obtain and enforce proper patent protection in all countries.
