

A S S I G N M E N T

WHEREAS, Hisafumi IKEDA (hereinafter referred to as ASSIGNOR), an individual residing at Esuteeto Edogawadai 8-307, 31-1, Edogawadainishi 3-chome, Nagareyama-shi, Chiba 270-0115 JAPAN is the owner of an undivided one-half right, title and interest to an invention for certain new and useful improvements in T-BUTOXYCARBONYLAMINOETHYLAMINE FOR THE SYNTHESIS OF PNA MONOMER UNITS, AMINO ACID DERIVATIVES, INTERMEDIATES THEREOF, AND PROCESSES FOR PRODUCTIONS OF THEM, of Application Serial No. 10/398,621 for Letters Patent of the United States, which assignment was filed on April 7, 2003 with the U.S. Patent Office but which has not yet been recorded by the U.S. Patent Office; and

interest in, to and under the said improvements, and the said Application and all Divisions, Renewals and Continuations thereof, and all Letters Patents of the United States which may be granted thereon and all Reissues and Extensions thereof, as the same would have been held and enjoyed by ASSIGNOR had this Assignment not been made; and

ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States to issue all Letters Patents for said improvements to the said ASSIGNEE, its successors, legal representatives and assigns, as assignee of said entire right, title and interest therein, in accordance with the terms of this instrument.

AND ASSIGNOR hereby covenants that he has full right to convey said entire right, title and interest herein assigned, and that he has not executed, and will not execute, any Agreement to conflict therewith.
