ASSIGNMENT

WHEREAS, we, ROMAN MARCEL BOLLIGER and LARS THOMAS BOLLIGER, citizens of Switzerland residing at Schuetzenweg 66, 4123 Allschwil, Switzerland and Grabenring 31, 4123 Allschwil, Switzerland, respectively, have made a certain new and useful invention as set forth in an application for United States Letters Patent for "ELECTRICAL TERMINAL" filed on August 19, 2002 under Serial No. 10/222,859, the hereinafter named assignee being hereby authorized to insert the said serial number and filing date when ascertained;

AND WHEREAS, WOERTZ AG, a corporation organized under the laws of Switzerland having a place of business at Hofackerstrasse 47, 4132 Muttensz 1, Switzerland, is desirous of acquiring the entire right, title, and interest in and to said invention and in and to any and all Letters Patent of the United States which may be obtained for said invention;

UPON SAID CONSIDERATION, we do hereby agree with the said assignee that we will not execute any writing or do any act whatsoever conflicting with these presents, and that we will, at any time upon request, without further or additional consideration, but at the expense of the said assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuation or reissued Letters Patent of the United States on said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of assignor and assignee;

AND we request the Commissioner of Patents and Trademarks to issue any Letters Patent of the United States which may be issued for said inventions to said WOERTZ AG, its legal representatives, successors or assigns, as the sole owner of the entire right, title, and interest in and to said patent and in the United States and in and to the invention covered thereby.
