## ASSIGNMENT

Orthotic Labs, Inc. as the assignee of the entire right, title, and interest in and to the same, for the use and enjoyment of Scott Orthotic Labs, Inc., its successors, legal representatives, and assigns.

Further, I agree that I will communicate to Scott Orthotic Labs, Inc., or its representatives all facts known to me in regard to said invention, and testify in any legal proceedings, sign all lawful papers, execute all provisional, non-provisional division, continuation, continuation-in-part, substitution, reissue, reexamination, and any other extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Scott Orthotic Labs, Inc., make all rightful oaths, and generally do everything necessary or desirable to aid Scott Orthotic Labs, Inc., its successors, legal representative, and assigns to obtain and enforce proper protection for said invention in the United States and in any foreign countries.
