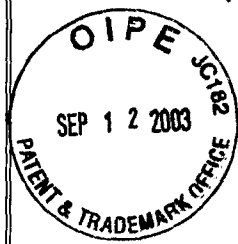

ASSIGNMENT

WHEREAS, David R. Hall, H. The Assignors hereby covenant and agree, for both the Assignors and the Assignors' legal representatives, that the Assignors will assist the Assignee in the prosecution of


