PATENT ASSIGNMENT

WHEREAS, WE, Edward A. Riess, a citizen of the United States, residing at 7962 Quebec Court, Cincinnati, Ohio 45241, County of Butler, and State of Ohio; Adam G. Malofsky, a citizen of the United States, residing at 12020 Millstone Court, Symmes Township, Ohio 45140, County of Hamilton, and State of Ohio; John P. Barber, a citizen of the United States, residing at 4377 Stonehenge Lane, Kettering, Ohio 45429, County of Montgomery, and State of Ohio; and, David P. Bauer, a citizen of the United States, residing at 2463 Washington Mill Road, Xenia, Ohio 45385, County of Greene, and State of Ohio (hereinafter referred to as "ASSIGNORS"), have invented a **METHOD OF ADHESIVE BONDING BY INDUCTION HEATING** filed on November 22, 2002 under Serial No. 10/302,158, for which we have executed an application for Letters Patent of the United States, and

TO BE HELD AND ENJOYED by said ASSIGNEE, its successors, and assigns, to the full ends of the respective terms for which said patents have been or may be granted, as fully and entirely as the same would have been held and enjoyed by us, had no sale and assignment of said interest been made.

ASSIGNORS HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.


