PATENT APPLICATION ASSIGNMENT



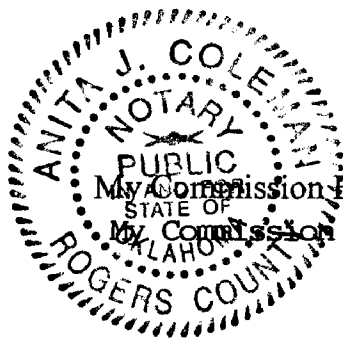

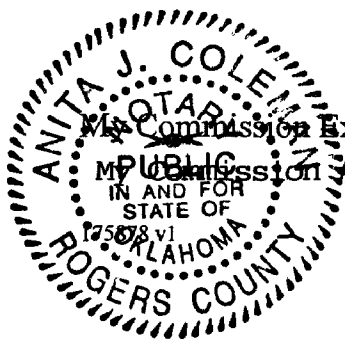
