### ASSIGNMENT OF RIGHTS

THIS ASSIGNMENT OF RIGHTS ("Assignment") is made as of August 12, 2002 by Turnedge America, LLC, f/k/a TEA, LC, a Virginia limited liability company, and Jerry W. Pearce (collectively, "Assignors"), and Rock-Tenn Converting Company, a Georgia corporation ("Assignee").

### RECITALS

Assignee and Assignors are parties to a certain Equipment Purchase Agreement dated as of August 12, 2002 (the "Agreement"), pursuant to which Assignors have agreed to transfer to Assignee and Assignee has agreed to accept the transfer from Assignors certain "Equipment" and "Intellectual Property" (as defined in the Agreement) related to Assignors' Business as defined in the Agreement, including, without limitation certain patents, trademarks and trade names of Assignors used in connection with the Business. Pursuant to the Agreement, Assignor has agreed to execute such instruments as the Assignee may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Assignee and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Assignee of, all rights hereunder.

In accordance therewith, Assignors desire to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignors' worldwide right, title and interest in, to and under Assignors' registered and unregistered domestic and foreign patents, trademarks, service mark and trademark applications and trade names listed on Schedule A annexed hereto and incorporated herein by reference (all of the foregoing being referred to herein as the "Marks"), which Marks are used in connection with the Business.

NOW, THEREFORE, Assignors, for and in exchange for the payment of the purchase price set forth in the Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignors' worldwide right, title and interest in, to and under the Marks, together with all rights to sue for infringement of any Mark, whether arising prior to or subsequent to the date of this Assignment, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of North Carolina without giving effect to the principles of conflicts of laws thereof.
