2. Assign to Assignee the right to apply on its own behalf for both United Kingdom and Foreign Letters Patent in respect of the invention and to claim the priority of the said Application.

3. Agree at the request of Assignee to execute and do all such further documents and things as may be necessary or proper for giving effect to the foregoing.
