ASSIGNMENT

WHEREAS, I, John Baranowski residing at 1653 Britany Drive, Bensalem, Pennsylvania 19020; a citizen of the United States (hereinafter the "ASSIGNOR") have invented certain new and useful improvements in:

DISPENSING AND DIVERSION SYSTEMS AND METHODS

which is described in a United States Provisional Patent Application filed on June 24, 2002, and accorded Application No. 60/390,371; which is also described in a United States Provisional Patent Application that was filed on March 17, 2003, and accorded Application No. 60/454,596.

AND I HEREBY authorize and request the Director of the U.S. Patent and Trademark Office or any other proper officer or agency of any region or foreign country to issue all said Letters Patent to the ASSIGNEE;

AND I HEREBY warrant and covenant that I have the full right to convey the entire interest herein assigned and that I have not executed and will not execute any instrument or assignment in conflict herewith;

AND I HEREBY agree to communicate to said ASSIGNEE or its representatives any facts known to me respecting the improvements; to execute all divisional, continuation, reissue, reexamination, or the like, or any international, regional, or foreign applications; sign all lawful

documents and make all rightful oaths and declarations relating to the improvements; and to testify in any judicial or administrative proceeding; and generally do everything possible to aid the ASSIGNEE to obtain and enforce said letters patent in the United States or any foreign region or country when requested so to do by the ASSIGNEE.
