ASSIGNOR does hereby covenant and agree, for itself, its assigns and legal representatives, as successor in interest, that it will execute and deliver to said ASSIGNEE any and all additional papers that may be requested by said ASSIGNEE to fully carry out the terms of this Assignment.

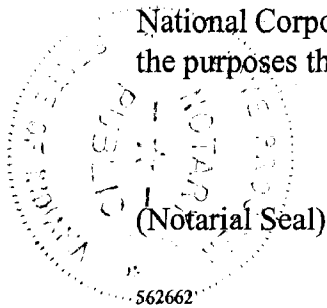
