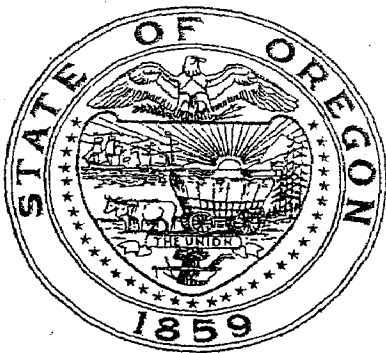

TO  
1990 RESTATED ARTICLES OF INCORPORATION  
OF  
IN FOCUS SYSTEMS, INC.

Pursuant to ORS 60.447, the undersigned corporation hereby submits for filing the following Articles of Amendment to its 1990 Restated Articles of Incorporation (the "Restated Articles of Incorporation"):

1. **Name of Corporation Prior to Amendments:** In Focus Systems, Inc.
2. **Amendment No. 1.** Article I of the Restated Articles of Incorporation is amended to read as follows:

ARTICLE I

*The name of the corporation shall be InFocus Corporation and its duration shall be perpetual.*

3. **Amendment No. 2.** Article III of the Restated Articles of Incorporation is amended to read as follows:

ARTICLE III

*The aggregate number of shares that the Corporation shall have authority to issue is 150,000,000 shares of Common Stock.*

4. **Date of Adoption of Amendments:** May 31, 2000
5. **Shareholder Vote:** Shareholder action was required to adopt both Amendment No. 1 and Amendment No. 2. The shareholder vote was as follows:
