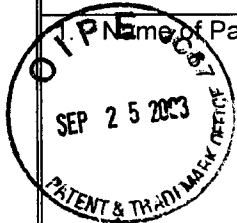

WHEREAS, David H. Griesinger, herein after called the "Assignor", has made the invention described in the United States patent application entitled MULTICHANNEL DOWNMIXING DEVICE, for a full description of which reference is here made to an application for Letters Patent of the United States filed on May 2, 2003, and assigned Application Serial No. 10/429,276.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
