

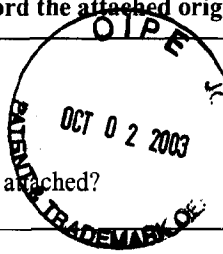



WHEREAS, Keymile AG, a corporation organized and existing under and by virtue of the laws of Switzerland, having an office at Schwarzenburgstrasse 73, CH-3097 Liebefeld, Switzerland, is desirous of acquiring the entire right, title and interest in and to the invention(s) described and claimed in said Letters Patent(s);

ASCOM TECH AG, hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interest granted herein and that ASCOM TECH AG will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and ASCOM TECH AG binds itself and its heirs, executors, administrators, employees and legal representatives, as the case may be, to execute and deliver to the said Keymile AG, its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said Keymile AG, its successors and assigns to file applications for improvements and inventions in any country where it may elect to file such applications, and that may be necessary to vest in the said Keymile AG, its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.


