# ACKNOWLEDGEMENT OF ASSIGNMENT

THIS ACKNOWLEDGEMENT OF ASSIGNMENT (this "Agreement") is dated as of August 20, 2003 and is entered into by and among EAR BAG AB, company registration no. 556489-2304, a company incorporated under the laws of Sweden ("Seller"), Tom Natvig, a Swedish citizen (the "Natvig") and ENVIOS USA AB, company registration no. 556630-2559, a company incorporated under the laws of Sweden (the "Purchaser").

## W I T N E S S E T H:

WHEREAS, Seller, Natvig and Purchaser entered into an Intellectual Property Purchase Agreement (the "IP Purchase Agreement") dated as of December 20, 2002 pursuant to which, *inter alia*, Seller and Natvig transferred and assigned to Purchaser all of their rights to the United States and Canadian patents set forth in Annex 1 attached hereto relating to the ear-held ear warmers commonly sold under the name "Earbags" (the "Intellectual Property"); and

WHEREAS, Seller, Natvig and Purchaser desire to acknowledge in this Agreement such assignment so that this Agreement may be filed with the applicable patent authorities in the United States and Canada in order to effect the formal re-registration of such Intellectual Property;

NOW, THEREFORE, the parties hereto hereby agree as follows:

### 1. Assignment

Pursuant to the IP Purchase Agreement, Seller and Natvig sold, assigned, transferred and conveyed to Purchaser, and Purchaser purchased from Seller and Natvig, free and clear of all encumbrances, all of Seller's and Natvig's right, title and interest in, to and under the Intellectual Property, including, without limitation, the right to take action and sue for damages or other remedies in respect of any infringement or misuse by third parties of any Intellectual Property that may have occurred prior to the date of the IP Purchase Agreement.

### 2. Assumption of Liabilities

Pursuant the terms of the IP Purchase Agreement, Purchaser also assumed and agreed to pay, perform and discharge when due in accordance with their respective terms, all liabilities and obligations of Seller and Natvig occurring after the date of the IP Purchase Agreement relating to the Intellectual Property.

### 3. Governing Law

This Agreement shall be construed in accordance with and be governed by the substantive laws of Sweden without regard to its principles of conflict of laws.
