I hereby authorize and request the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said OKLAHOMA FOUNDATION FOR DIGESTIVE RESEARCH, as the assignee of our entire right, title and interest in and to the same, for the sole use and enjoyment of said OKLAHOMA FOUNDATION FOR DIGESTIVE RESEARCH, its successors and assigns.

FURTHER, I agree that I will communicate to said OKLAHOMA FOUNDATION FOR DIGESTIVE RESEARCH, or its representatives any facts known to me respecting said invention, and testify in any legal proceedings, sign all lawful papers, execute all division, continuation, substitution, renewal, reissue and reexamination applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said OKLAHOMA FOUNDATION FOR DIGESTIVE RESEARCH, make all rightful oaths and generally do everything necessary or desirable to aid said OKLAHOMA FOUNDATION FOR DIGESTIVE RESEARCH, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.


