ASSIGNMENT

WHEREAS I, Roger Graham Byford, a citizen of the United States, residing at 612 Monroe Court, Apollo, Pennsylvania 15613-9245; Arthur Eugene McNair, a citizen of the United States, residing at 1368 Simona Drive, Pittsburgh, Pennsylvania 15201; James Randall Logan, a citizen of the United States, residing at 24 Hancock Farms, Pittsburgh, Pennsylvania 15238; and Ryan Anthony Zoschg, a citizen of the United States, residing at 745 Fourth Street, Oakmont, Pennsylvania 15139 (hereinafter referred to as "ASSIGNOR"), have invented a WIRELESS HEADSET FOR USE IN SPEECH RECOGNITION ENVIRONMENT, for which an application for Letters Patent of the United States is filed herewith at the United States Patent and Trademark Office.
