WHEREAS, WE, **Dmitry Znamensky** of 1526 Lakeview Drive #221, Darien, Illinois 60559 and **Alan Zdunek** of 1537 West Glenlake Avenue, Chicago, Illinois 60660 respectively, have invented certain new and useful improvements in **Micro Electromechanical Systems For Delivering High Purity Fluids In a Chemical Delivery System** for which provisional patent applications were filed on **December 27, 2002**, having Application No. 60/436,731 and **December 27, 2002**, having Application No. 60/436,732 and an application for Letters Patent was filed on **December 12, 2003**, having Application No.
