

## GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS



This Grant of Security Interest has been given in conjunction with the security interest granted to the Collateral Agent under the Security Agreement, and the provisions of this Grant of Security Interest are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.
