PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of September 29, 2003, by **HELLER FINANCIAL, INC.**, a Delaware corporation, as Agent ("**Agent**").

WITNESSETH:

WHEREAS, Agent and Bowe Bell + Howell Postal Systems Company, a Delaware corporation f/k/a Bell & Howell Postal Systems Inc. ("**Grantor**"), were parties to that certain Patent Security Agreement, dated April 11, 2003 (the "**Assignment**"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Assignment), pursuant to which Postal Sytems granted a security interest to Agent, on behalf of the Lenders (as defined below), in the Patents, as security for certain obligations owing by Grantor to Agent and the financial institutions (collectively, the "**Lenders**") from time to time parties to that certain Credit Agreement dated as of September 28, 2001, by and among BBH, Inc., a Delaware corporation f/k/a Bell & Howell Company and BH Acquisition, Inc., Agent and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Patents set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Assignment Division of the United States Patent and Trademark Office on April 22, 2003, at Reel 013964, Frame 0628; and

WHEREAS, Grantor has requested that Agent release its security interest in the Patents and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor' right, title and interest in and to all of the following:


(i) each Patent and application for Patent applications listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof ; and
