

PATENT ASSIGNMENT

This Patent Assignment (the "Assignment") is made from Vigilance, Inc., a Delaware corporation (the "Seller"), and Harmony Software, Inc., a wholly owned subsidiary of Seller, and Vigilance Limited, a wholly owned subsidiary of Seller (together, the "Seller Subsidiaries") to Arzoon Asset Acquisition, Inc., a Delaware corporation ("Buyer Subsidiary"), a wholly owned subsidiary of Arzoon, Inc., a Delaware corporation ("Buyer").

Seller and Seller Subsidiaries desire to assign to Buyer Subsidiary all of the right, title and interest of Seller and Seller Subsidiaries in and to the patents and patent applications, any and all divisional applications, continuing applications, or reissue patents restated thereto or based thereon, any and all patents issuing thereon, and any and all foreign patents and patent applications corresponding thereto or relying thereon for its filing or convention date (the "Patents") set forth on Schedule 2.1(h) to the Asset Purchase Agreement dated December ^{4th}, 2003 entered into by and among Buyer, Buyer Subsidiary, Seller and Seller Subsidiaries (the "Asset Purchase Agreement"), which Schedule is attached hereto as Exhibit A.

In consideration for entering into the Asset Purchase Agreement and for other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Seller and Seller Subsidiaries do hereby assign, transfer, grant, sell and otherwise convey to Buyer Subsidiary all of the right, title and interest of Seller and Seller Subsidiaries in and to the Patents, including all common law rights therein, applications to register therefor, together with all claims for damages by reason of past infringements of the Patents with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns and other legal representatives. Seller and Seller Subsidiaries authorize the Commissioner of Patents and Trademarks of the United States of America, and the empowered officials of all other governments to issue or transfer all said patents and patent applications to Buyer Subsidiary, as assignee thereof, or otherwise as Buyer Subsidiary may direct. By executing below, the persons executing this Assignment acknowledge that they are authorized to do so on behalf of Seller and Seller Subsidiaries.

Seller and Seller Subsidiaries hereby agree to use commercially reasonable efforts to sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, reexamination, and substitute applications, and make all lawful oaths, to vest title in Buyer Subsidiary for all said Patents.
