

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNOR and will testify as to the

same in any interference, litigation or proceeding related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention, and said Letters Patent and said equivalents thereof which may be necessary or desirable to carry out the purposes thereof;

ASSIGNOR authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States for said invention, resultant from any of the aforesaid applications, to said ASSIGNEE.
