AND

Sensient Colors Inc. a corporation organized and existing under the laws of the State of New York with a permanent place of business at 111 Eighth Avenue, New York, NY 10011, USA (hereinafter called "the Assignee").

WHEREAS

- (A) The Assignor is the owner of all rights in and is proprietor of United States Patent Number 5,879,413 (filed on 26th November 1997 as United States Patent Application Number 08/980,028) entitled "CATIONIC DIAZO DYES FOR THE DYEING OF HAIR" (hereinafter referred to as "the Patent").

NOW THIS ASSIGNMENT WITNESSETH as follows:



2. The Assignor and the Assignee agree to execute any such further supplemental documentation as may reasonably be required by the Assignee in order to register the

Assignee as proprietor of the Patent at the respective local Patent Offices around the world (hereinafter referred to as "the **Local Documents**").

3. Each of the Local Documents and this Assignment shall be regarded as one and the same instrument and in the event of any conflict between the terms of any of the Local Documents and this Assignment, the terms of this Assignment shall prevail.
4. This Assignment shall be governed by the law of England and Wales and the parties agree to submit to the jurisdiction of the English courts.


