RING of Palm Bay, Florida, hereby assign to CHROMAVISION MEDICAL SYSTEMS INC., a Delaware corporation having a place of business at: 33171 Paseo Cerveza, San Juan Capistrano, CA 92675, and its successors and assigns (collectively hereinafter called "the Assignee"), of the entire right, title and interest throughout the world in the inventions and improvements which are the subject of the applications for United States Patent entitled:

METHOD AND APPARATUS FOR AUTOMATED IMAGE ANALYSIS OF BIOLOGICAL SPECIMENS,

assigned U.S. Serial Number 09/495,461 (the '461 application) and U.S. Serial Number 10/746,515 (the '515 application); this assignment, including said applications, any and all United States and foreign patents, utility models, and design registrations granted for any of said inventions or improvements, and the right to claim priority based on the filing date of said applications under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes; and we authorize the Assignee to apply in all countries in our name or in its own name for patents, utility models, design registrations and like rights of exclusion and for inventors' certificates for said inventions and improvements; and we agree for ourselves and our respective heirs, legal representatives and assigns, without further compensation, to perform such lawful acts and to sign such further applications, assignments, Preliminary Statements and other lawful documents as the Assignee may reasonably request to effectuate fully this assignment.

The '461 and '515 applications claim priority to the application for United States Patent filed November 27, 1996, and assigned U.S. Serial Number 08/758,436 (the '436 application), now U.S. Patent No. 6,215,892. The present assignment affirms that the Assignee acquired rights to the '436 application and that a confirmatory assignment to this effect was recorded in the U.S. Patent and Trademark Office on March 6, 2000, at Reel 010682, Frame 0349. As set forth in the confirmatory assignment, JAMES W. DOUGLASS THOMAS J. RIDING and JAMES E. RING assigned their interest in the '436 application to XL-VISION, INC., on November 27, 1996. XL-VISION, INC. subsequently assigned the '436 application to MICROVISION MEDICAL SYSTEMS, INC., a Delaware corporation having a place of business at 33171 Paseo Cerveza, San Juan Capistrano, California 92675. That assignment was recorded in the United States Patent and Trademark Office at Reel 8463, Frame 0364, on March 20, 1997. MICROVISION MEDICAL SYSTEMS, INC., subsequently changed its name to CHROMAVISION MEDICAL SYSTEMS, INC. The change of name was recorded in the United States Patent and Trademark Office at Reel 8780, Frame 0038, on November 4, 1997.
